Each student chosen shall receive a one-time payment of \$1000 for educational assistance; these payments will be made directly to the school.

We've recognized a growing trend in the building/automotive trades industry and the need for skilled tradesmen and tradeswomen. These positions are gaining a lot of attention and it's our goal to be involved in a meaningful way.

## **ELIGIBILITY CRITERIA**

- ✓ The student must possess a 2.0 GPA or higher.
- ✓ Has been accepted into an accredited technical institute or secondary vocational technical school with apprenticeship programs such as HVAC, carpentry, electrical, automotive technology, alternative energy, plumbing, cosmetology, certification programs such as vet tech, etc. or related fields of study. (Note: All scholarship recipients are required to submit proof of enrollment prior to receipt of the scholarship.)
- ✓ Currently attending high school in Hillsdale County, in good standing, and will graduate in the 2022-2023 school year.
- ✓ Community service hours – each applicant will be evaluated individually as to what he/she has participated in.
- ✓ Must submit the application with 3 letters of recommendation from a teacher, employer or similar position.

### **Application Deadline**

All applications must be submitted no later than March 30, 2023, to KB Law Office, PO Box 904, Hillsdale, MI 49242, faxed to 517.797.6023, or emailed to [office@kburgerlaw.com](mailto:office@kburgerlaw.com). No late applications will be accepted and if all required documentation is not submitted, the candidate may be deemed ineligible to receive the scholarship.

## **APPLICATION PROCESS**

### **Review and Notification**

Once all applications are received and reviewed by the scholarship committee, the top 5 applicants may be interviewed for a final determination.

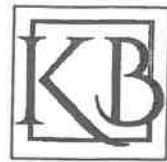
The winners will be announced at their school's class night or graduation awards ceremony.
